About Business activities:

Scope of Services to be provided by the Advisor will be limited/ subject to the Advisory services which are permitted activity under SEBI (Investment Advisers) Regulations, 2013 including guidelines issued by SEBI and the Advisor shall act in a fiduciary capacity.

The Scope of Services covered is as follows:

- a) Advise the Client regarding the Securities to be purchased or sold or Investments to be made as per the applicable law for the time being in force and Investment Pattern applicable to class of investor
- b) Portfolio advisory
- c) Comprehensive financial planning, which will include goal-based planning, estate planning, retirement planning, etc.
- d) Wealth management
- e) Review, evaluate, structure and monitor Investments so as to achieve the Client's objectives;
- f) Periodic Macroeconomic/ Fixed Income/ other reports and regulatory reports/releases.

Any other services as may be mutually agreed between the Advisor and the Client as per the applicable law for the time being in force.

Terms & Conditions for Advisory Services:

- i. Existing clients, who wish to take advisory services, will not be eligible for availing distribution services within the group of Growthvine. Similarly, existing clients who wish to take distribution services will not be eligible for availing advisory services within the group of Growthvine.
- ii. A new client will be eligible to avail either advisory or distribution services within the group of Growthvine. The option to avail either advisory services or distribution services shall be made available to each client at the time of on boarding.
- iii. Growthvine will provide Investment Advisory Services, for an agreed fee structure for a definite period of time and which may vary / change from time to time, entirely at the Client's risk.

- iv. Growthvine shall, wherever available, advice direct plans (non-commission based) of products only.
- v. The detailed terms and conditions are as per the Agreement executed between Client and Growthvine.
- vi. The rights and obligations, terms and conditions of the Advisory Services will be reduced in writing at the time of on boarding the Client.
